# Updated Social Networking and Internet Rules:

Here is the updated and official CA policy for electronic communication/social networking.

Children in foster care have the right to privacy about their status in foster care and also should have reasonable access to uncensored communication with others. It can be challenging to meet both of these expectations in the era of social networking sites such as Facebook, My Space and rapid electronic communication such as Twitter. There are also many questions about what caregivers can post about foster children in their homes. The CA Policy on communication for children in foster care has been updated to clarify our position on these issues. It is attached for your review and implementation.

In brief, Policy 43022 – Outside Communication for Children in Care to CA Social Work Staff says : Social workers and foster parents should discuss foster children's use and access to electronic communications (social networking sites, email, cell phones, etc), as part of the child's case plan in monthly meetings with the foster parent. Use and access to electronic communications is based on reasonable discretion related to the specific child.

Foster parents can have pictures of foster children on social networking sites as long as information about children in out-of-home care does not include:

1. Child's name,
2. Identify the child as being a foster child.
3. Discussion about case specific information about the child or the child's family

If there are safety concerns about posting a picture of a foster child on a social networking site, it is the social worker's responsibility to inform caregivers why unidentified photos may not be posted on the caregiver's social networking site(s).



## **Quarterly Regional & State Wide Foster Parent Consultation Meetings**

House Bill 1624 is a piece of legislation requiring the Children's Administration to consult with foster parents. The goal is to ensure foster parents participate directly or through a representative and have a chance to offer input at each stage of ongoing work regarding:

- Recruitment of foster homes
- Retention of foster homes—issues you face or problems you feel the state should fix so you can parent.
- Effective training for foster parents
- Development of coordinated & plans that strengthen services for the protection of children



## Disaster Preparedness Tips

- Pick a family member or friend** who lives at least 100 miles away to be the primary contact in case the emergency disrupts local land-based or wireless telephone services. Each person in the household, including children, should have that number and call the contact to say they're OK.
- Pick a place to meet** in case it's not possible to return home, the Federal Emergency Management Agency recommends.
- Adults and children should carry important phone numbers** and addresses with them and make sure the information is current. Adults can include these with food, clothing and other supplies in their survival kits, which can be stored in a car. Children can carry this information in their school packs or their own survival kits.
- Each person in a household should have supplies** — enough food, water, first-aid items, medication, etc., to last at least three days.
- Find out about the disaster plan** for the workplace, school, day-care center and other places where you or your family spend time.

## FOSTER PARENTS of INFANTS:

### IS YOUR CRIB SAFE??

Crib safety standards will change effective June 28, 2011 per the federal Consumer Product Safety Improvement Act of 2008. The new mandatory crib standards will: (1) stop the manufacture and sale of dangerous, traditional drop-side cribs; (2) make mattress supports stronger; (3) make crib hardware more durable; and (4) make safety testing more rigorous. All cribs manufactured, sold, or leased in the US must meet these new standards.

Effective June 28, 2011 all newly licensed foster homes, who want to take placement of children who require a crib, must have cribs that meet these standards. Foster homes that renew their license for this age group are not required to replace their cribs. However, information about the new crib safety standards should be provided to foster homes when they renew their license. The federal legislation does not address crib replacement for foster homes.

The Foster Home Licensing Checklist (DSHS 10-183) will continue to read "Crib meets all safety requirements." You cannot tell from a visual inspection of a crib if it meets the new standards; buyers may ask the retailer if the crib meets the new standards PRIOR to June 28, 2011. Cribs sold after June 28th should meet the standards.
